The Comprehensive Distance Learning Guidance has been reviewed, yes. It was our understanding from the spring till present that private schools were not required to follow the state's guidance for distance learning. WCS has developed a program to facilitate distance learning in conjunction with Westgate Christian School's purpose in supporting our desired student learner outcomes.
